#### Machines equipped with Smart-Shox:

- Disconnect Wiring Harnesses from Shocks. Reconnect after installation is complete.
- Separate from Brakelines. Resecure after installation is complete.
- Disconnect Links from A-Arms.


Lower Springs should be in stock orientations on Shocks. Potential interference may occur if Shocks have been disassembled and not reassembled correctly.






### Unless noted, driver side installation shown in illustrations.

- Install Lower and Upper A-Arms (D)(A) to Frame with stock hardware; tighten.



- If applicable, secure Link to Driver Upper (A) with stock hardware; tighten.




- Reinstall Shock to Frame with stock hardware; tighten.





- Secure Shock and Knuckle to Driver Lower (D) with hardware shown; tighten.




- Secure Knuckle to Driver Upper (A) with stock hardware; tighten.



- Secure Sway Bar Link to Driver Lower (D) with stock hardware; tighten.



- Reinstall Hub, Brake, and Tie Rod; tighen.



- Secure Axle; tighen.

- Reinstall Caliper; tighten.



- Repeat steps for passenger side installation.
- Secure Brake Lines to Lowers with components shown; tighten.
