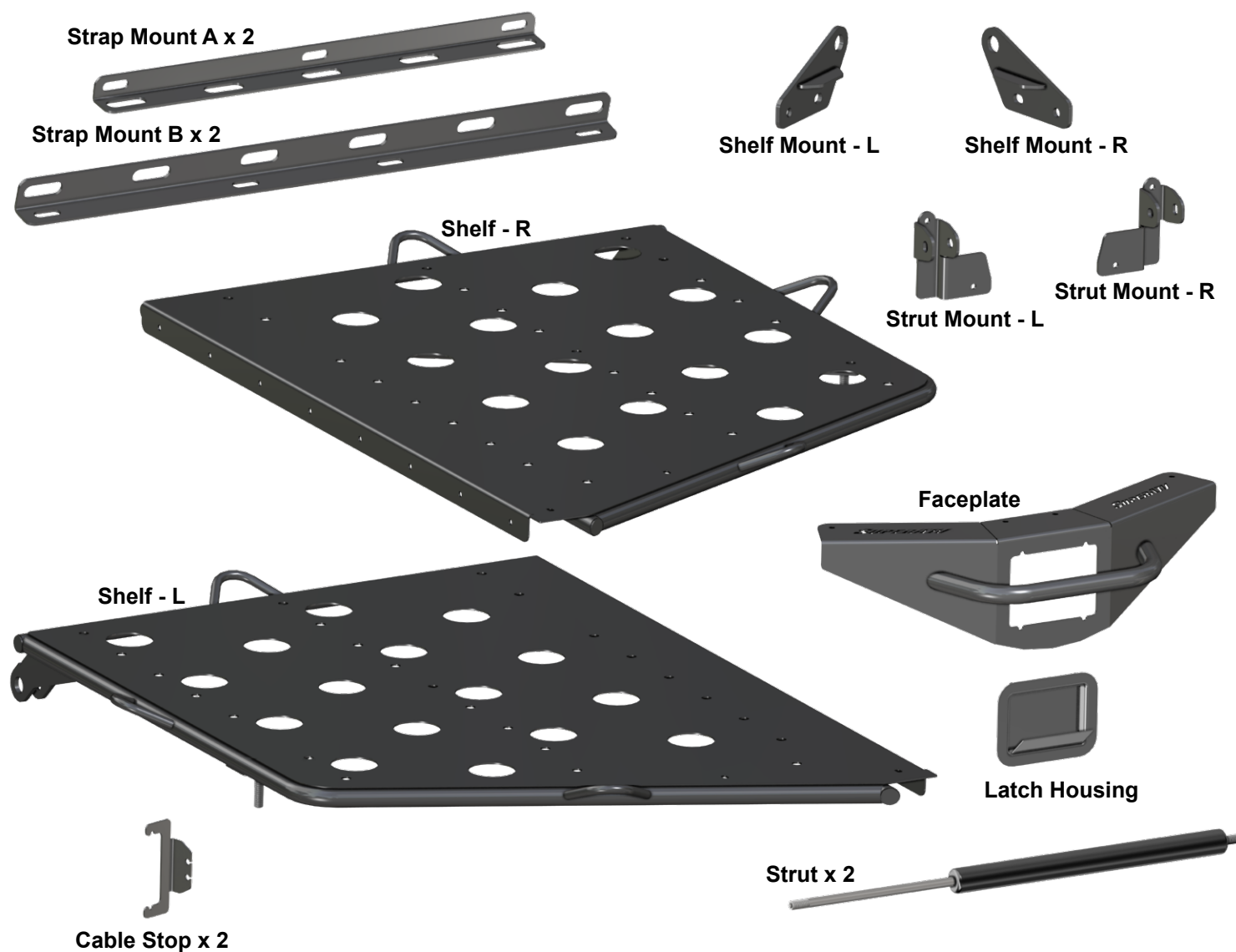


Cargo Rack: for Can-Am X3

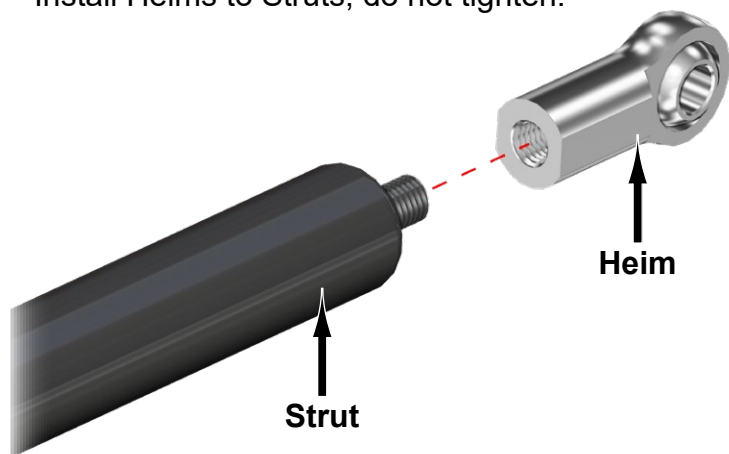

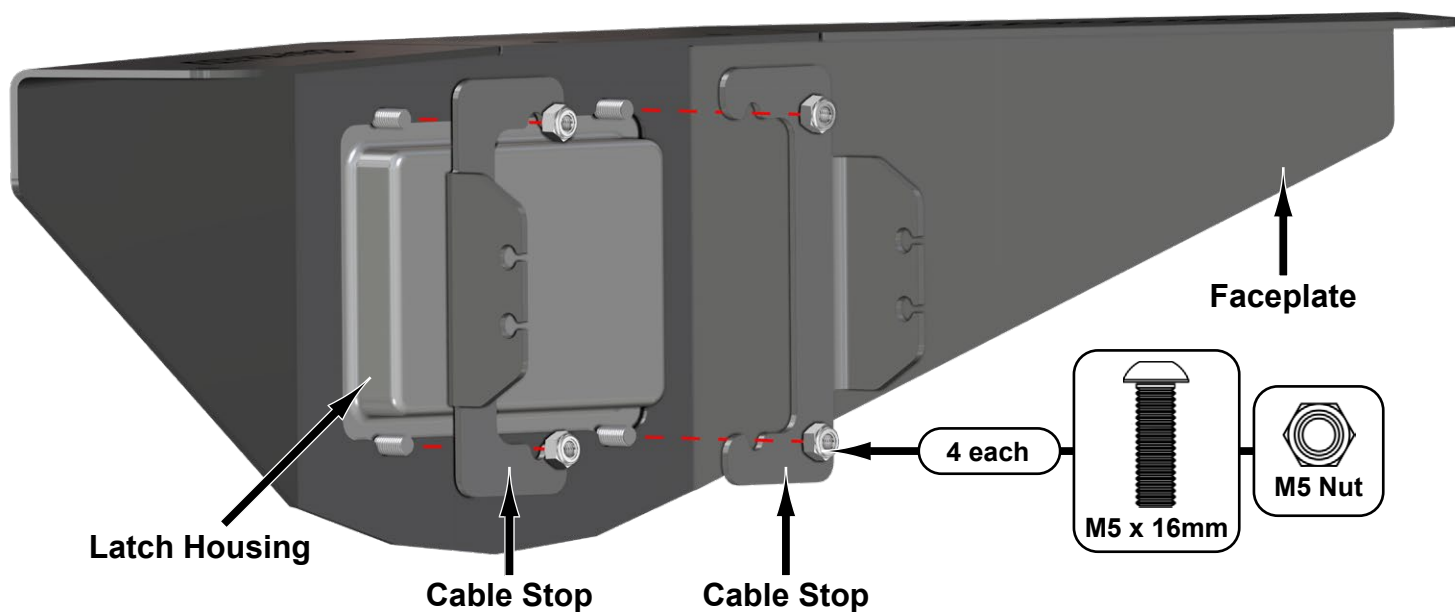

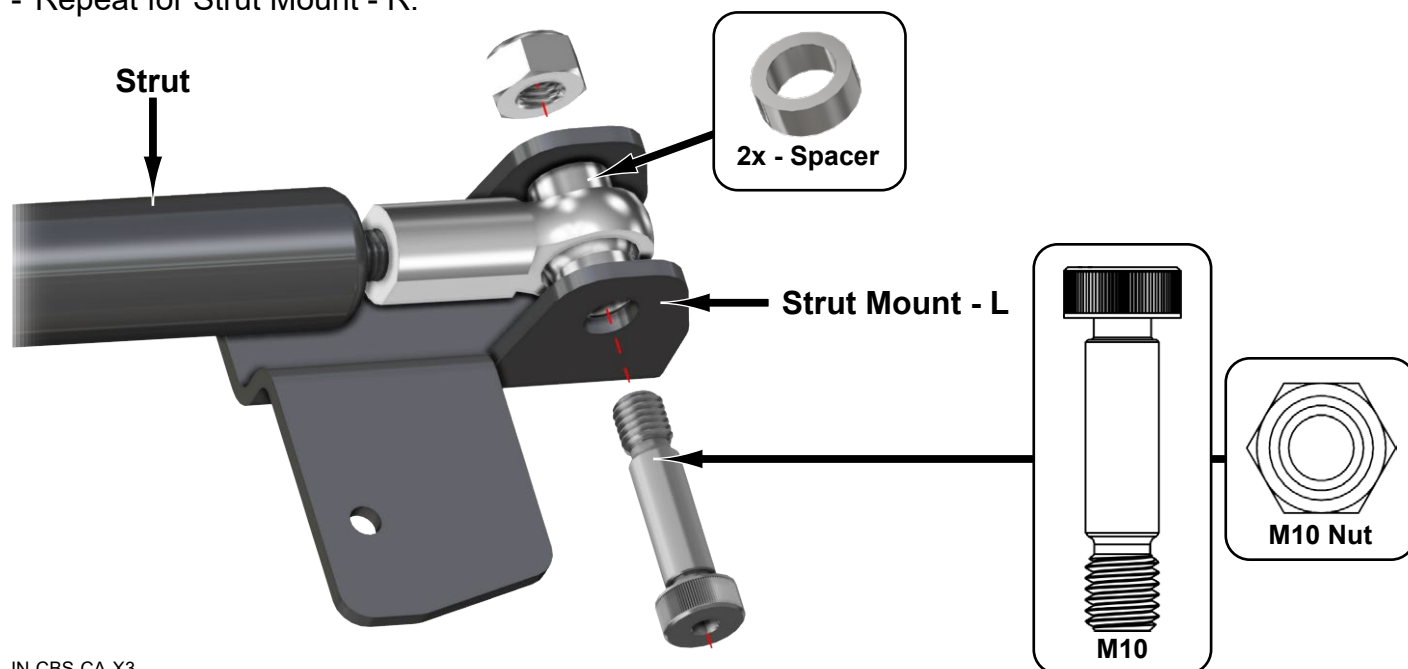
- Install Heims to Struts; do not tighten.



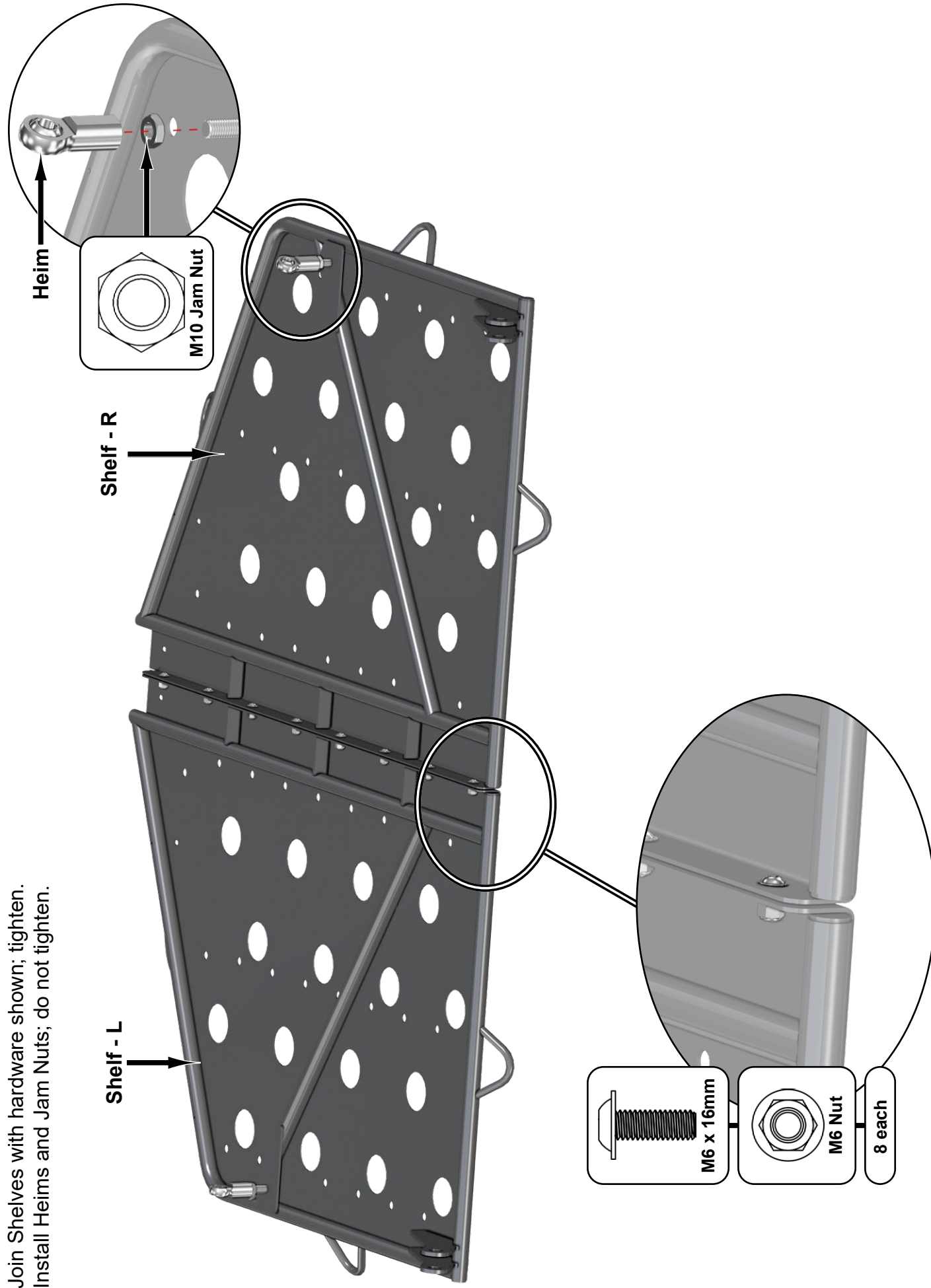
- Install Latch Housing and Cable Stops to Faceplate with hardware shown; tighten. Set aside.



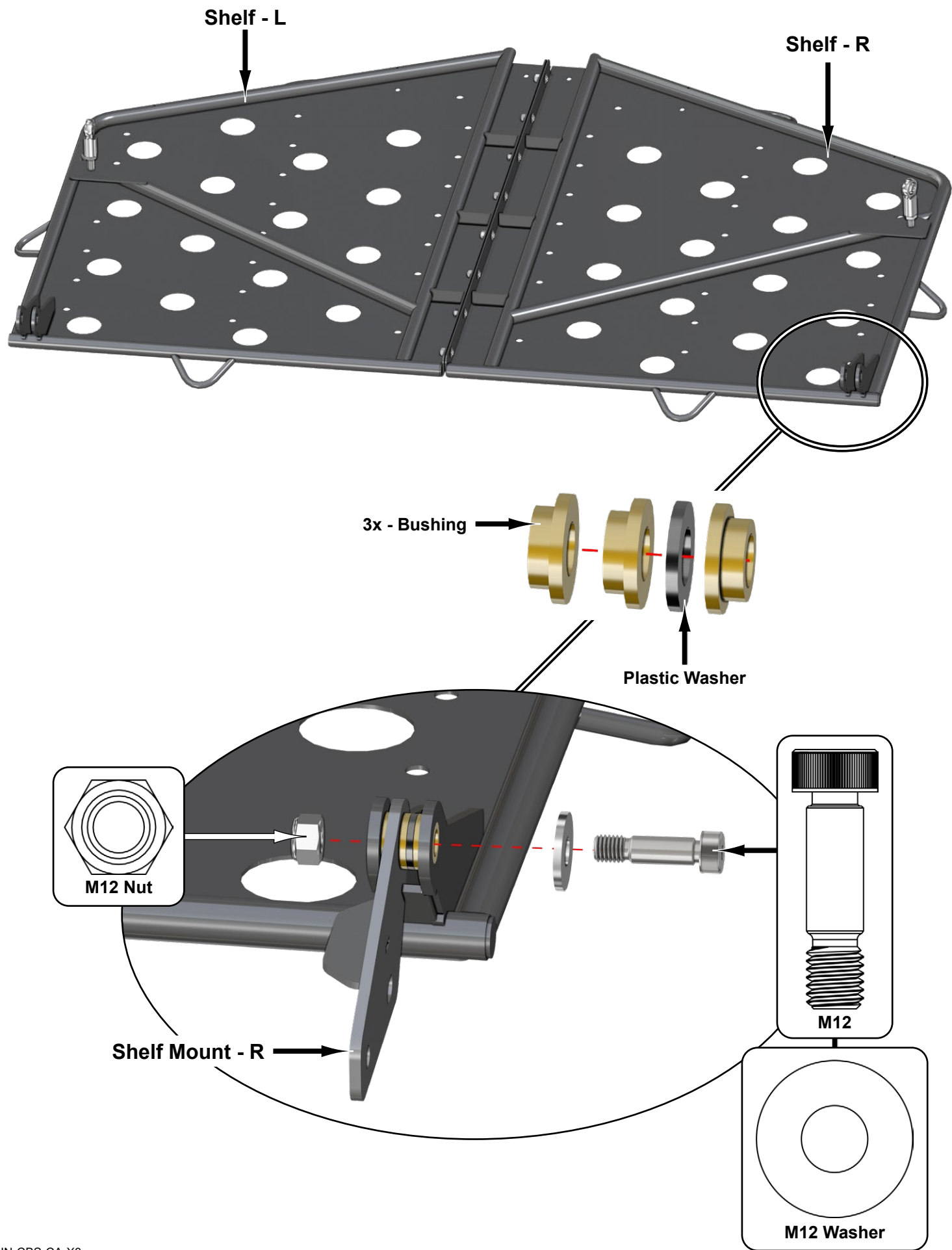
- Install Strut to Strut Mount - L with hardware shown; tighten. Set aside.
- Repeat for Strut Mount - R.

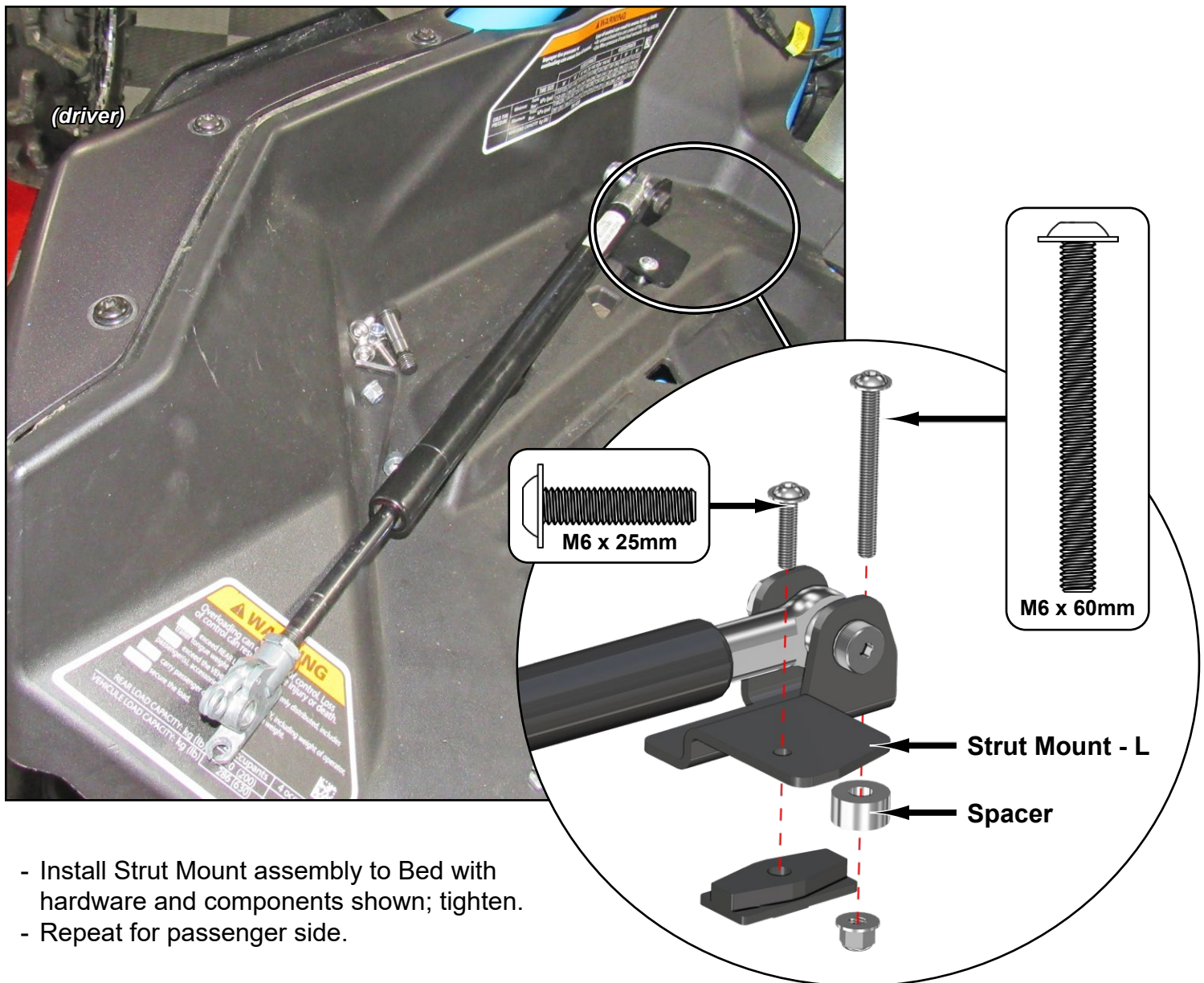


- Join Shelves with hardware shown; tighten.
- Install Heims and Jam Nuts; do not tighten.

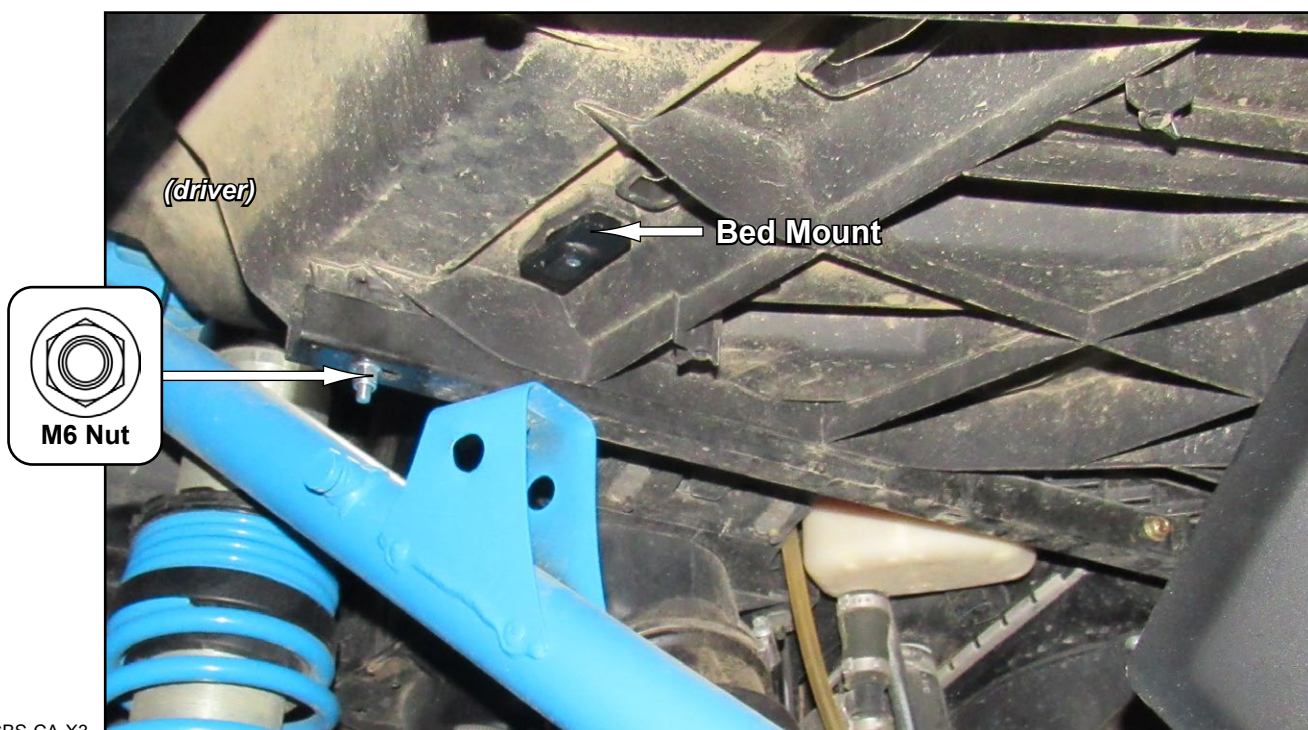


- Install Shelf Mounts to Shelves with hardware shown; tighten.





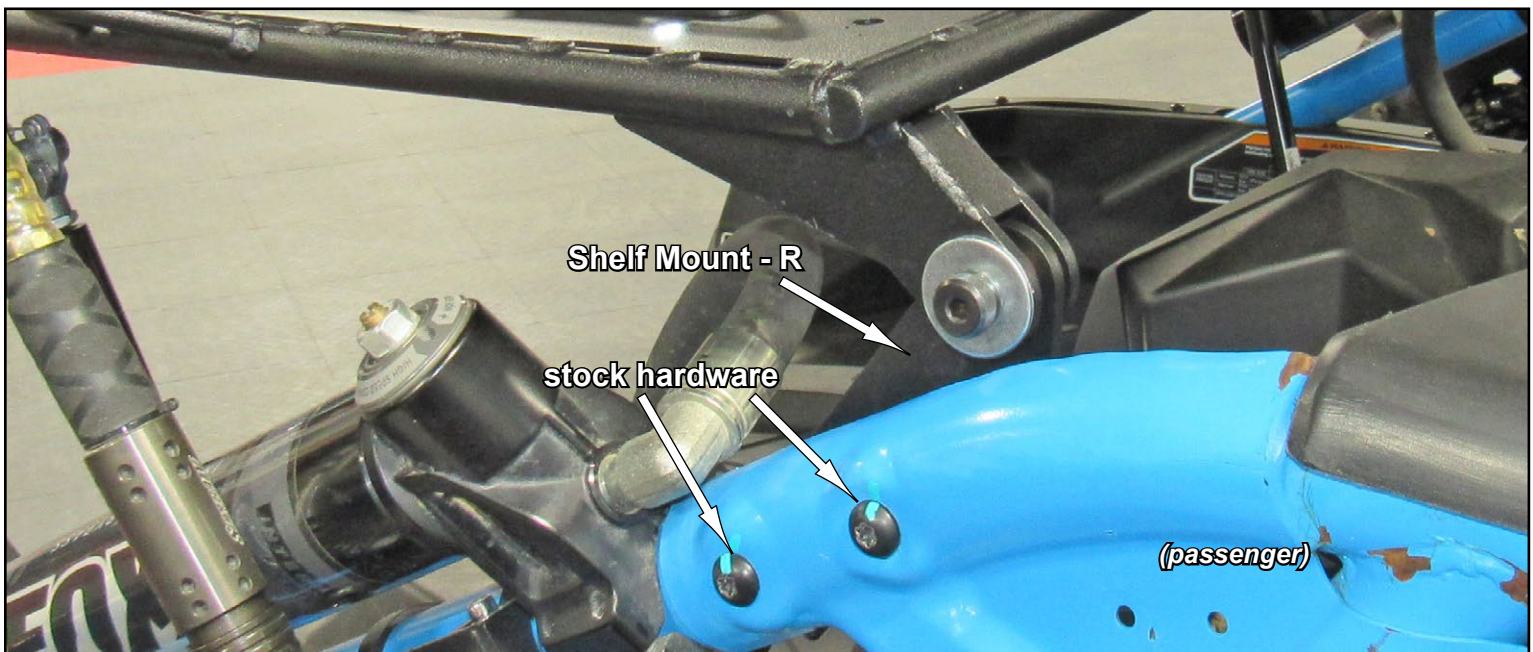
- Install Strut Mount assembly to Bed with hardware and components shown; tighten.
- Repeat for passenger side.



- Install Shelf assembly to Struts with hardware shown; do not tighten.

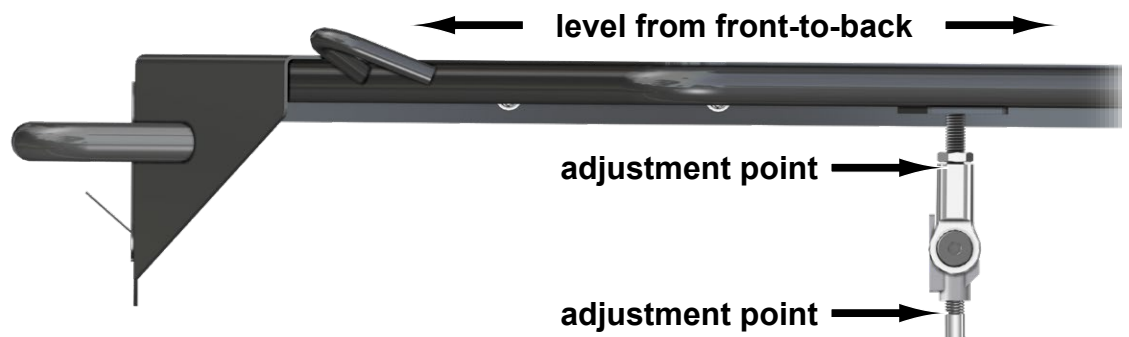


- Secure Shelf Mounts to Frame with hardware shown; tighten.

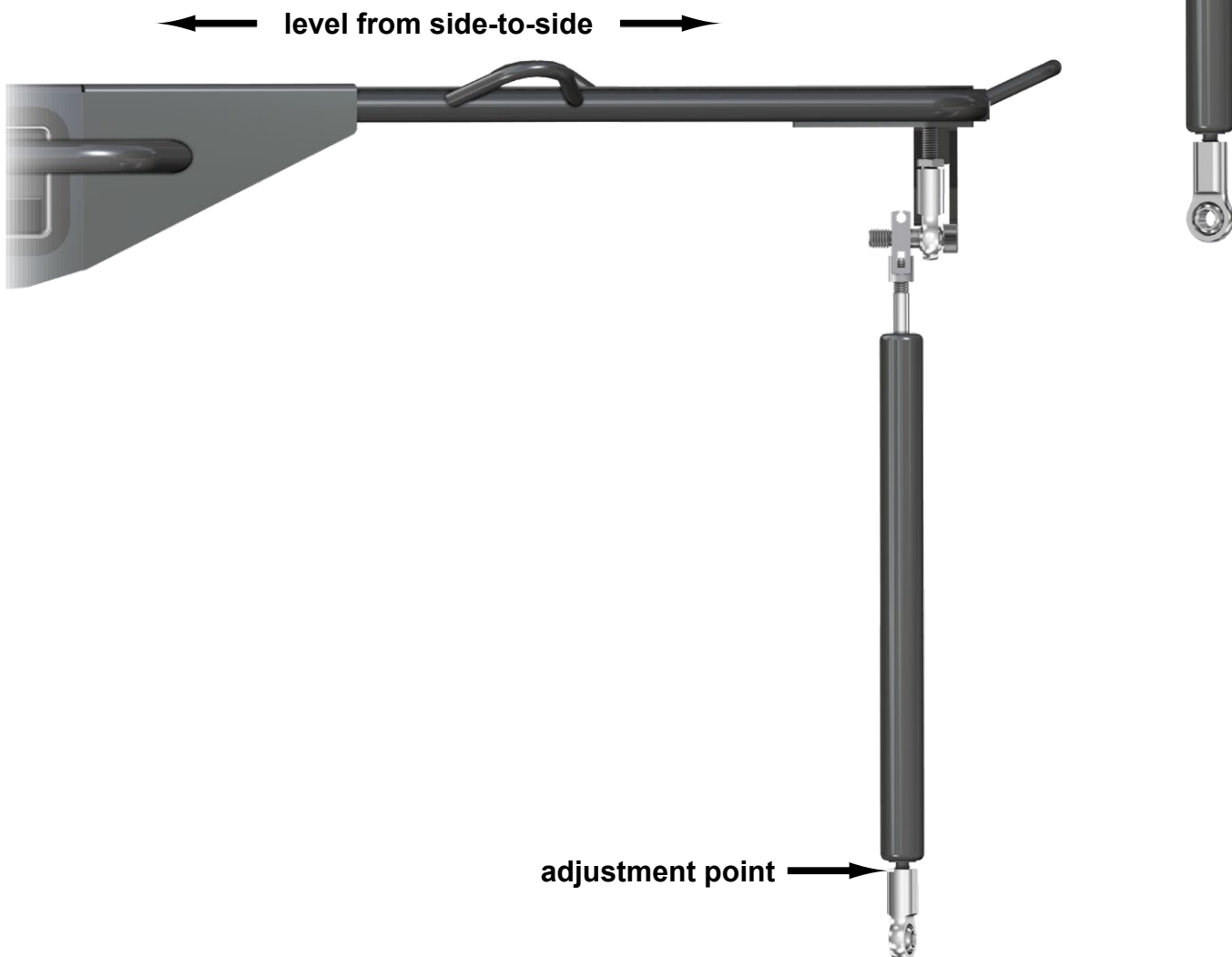


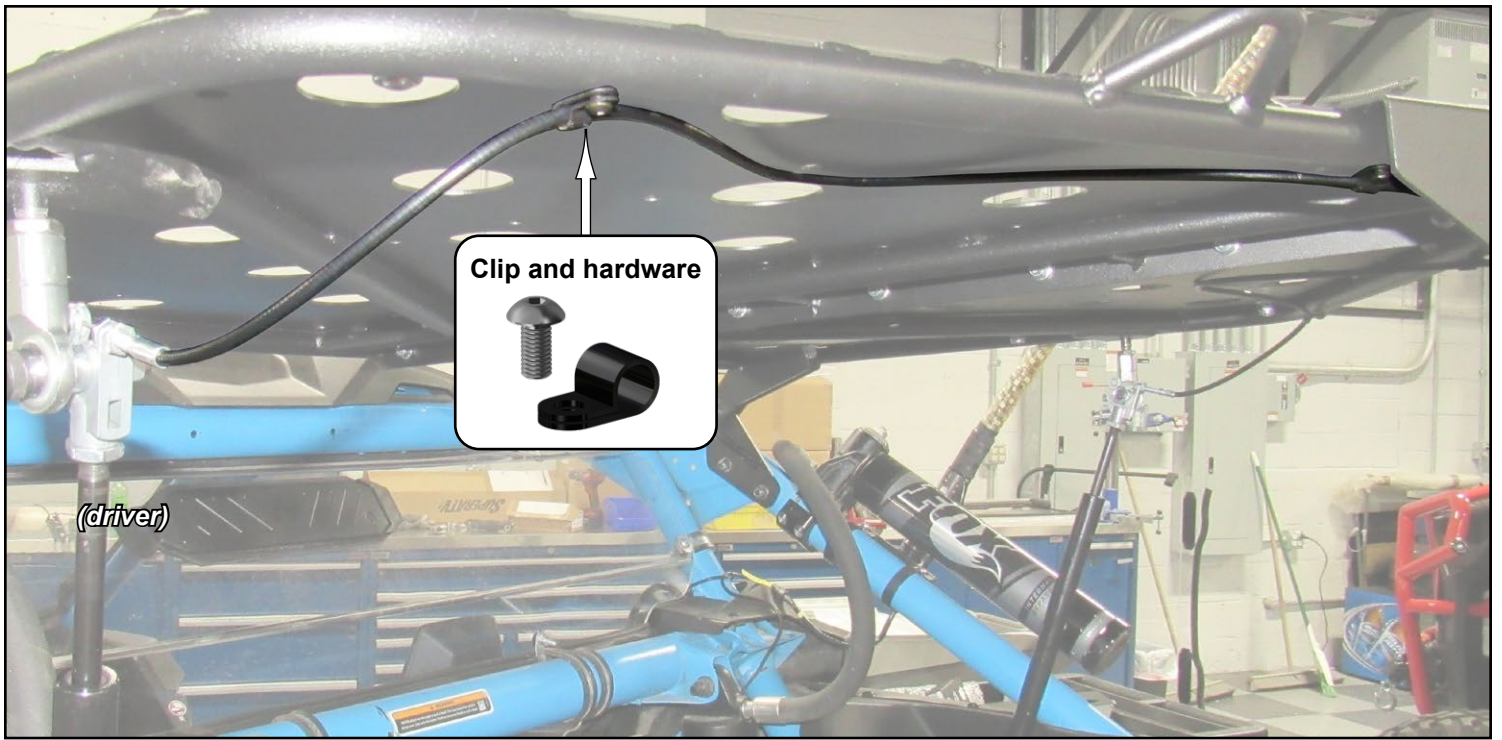
- Install Faceplate to Shelves with hardware shown; tighten.



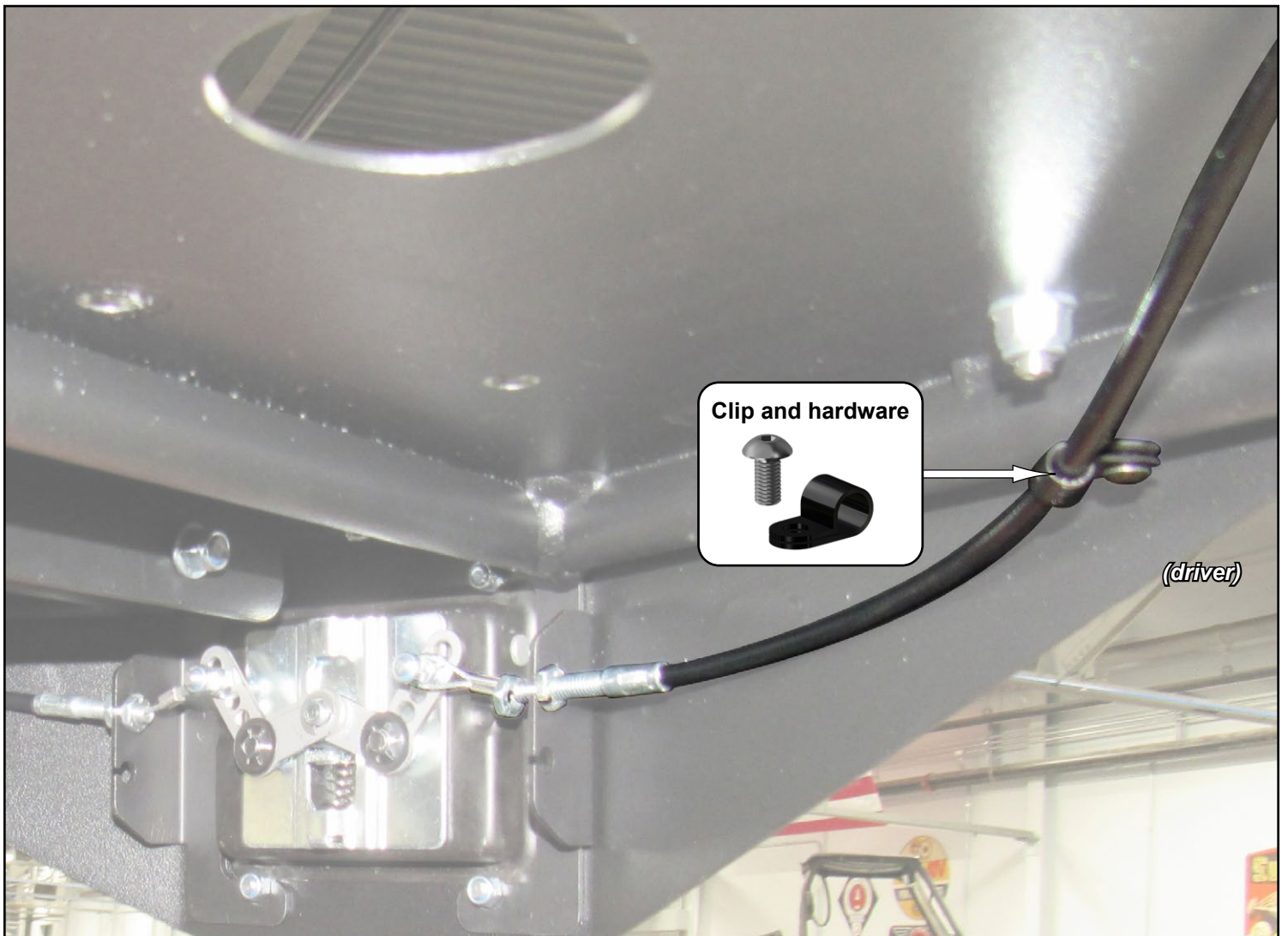


- Adjust and level assembly.
- Tighten all hardware.

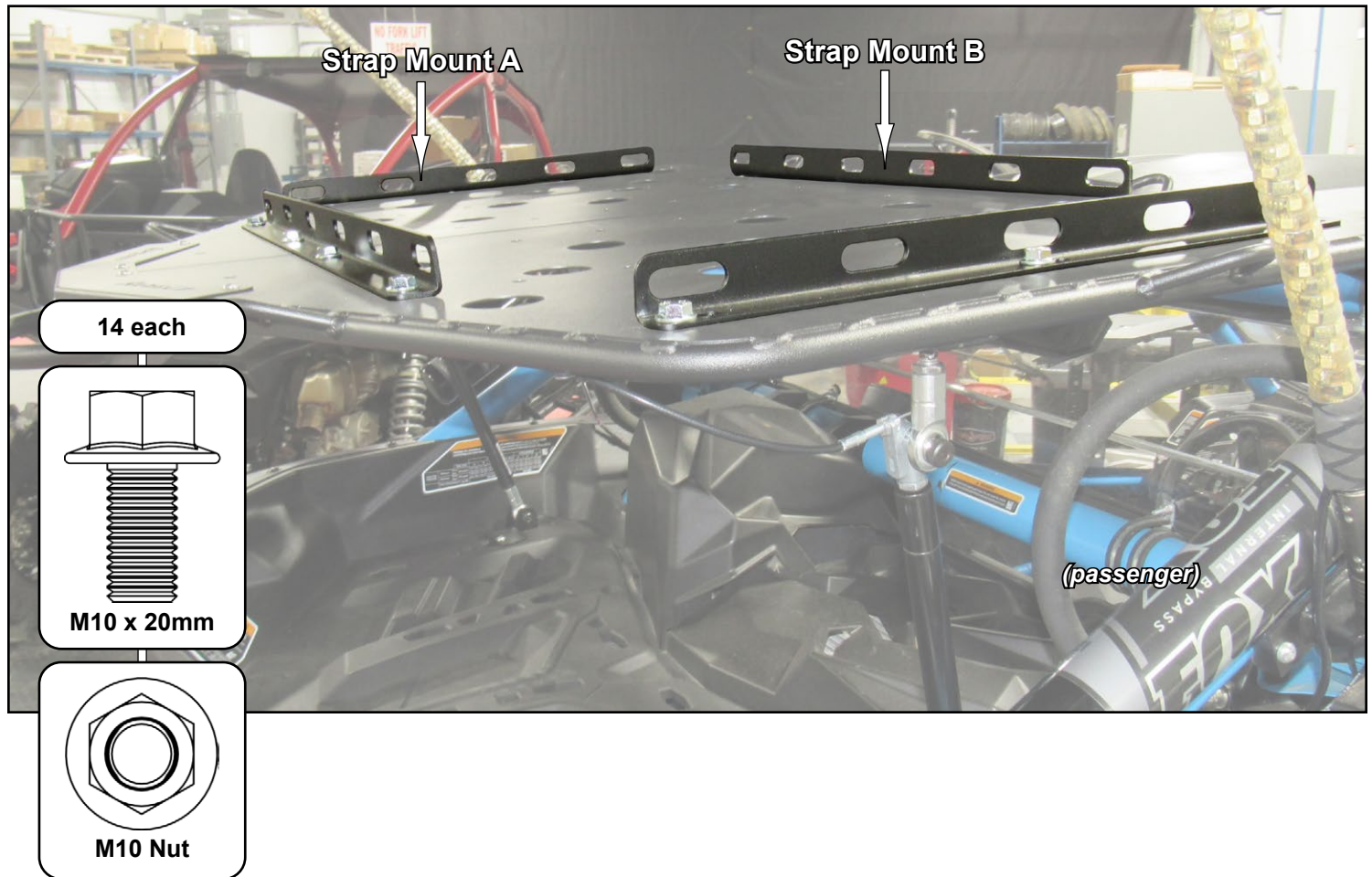




- Install Cables to Struts and Latch Housing; tighten.
- Secure Cables to Shelves with components shown; tighten.



- Install Strap Mounts to Shelves with hardware shown; tighten.
