when installing components, do not tighten hardware completely unless noted



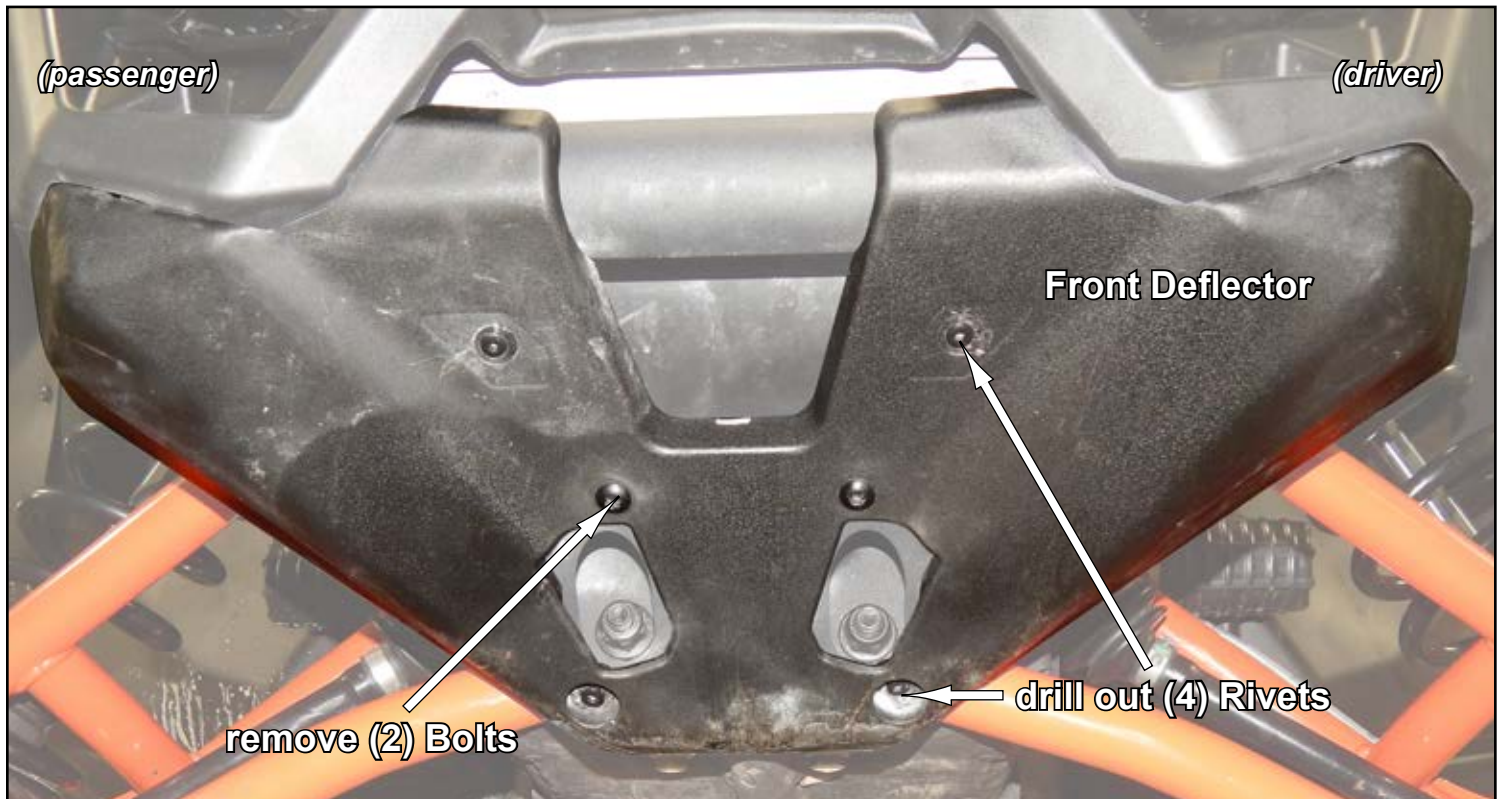
Keep all components removed from machine.

- Remove Front Deflector.



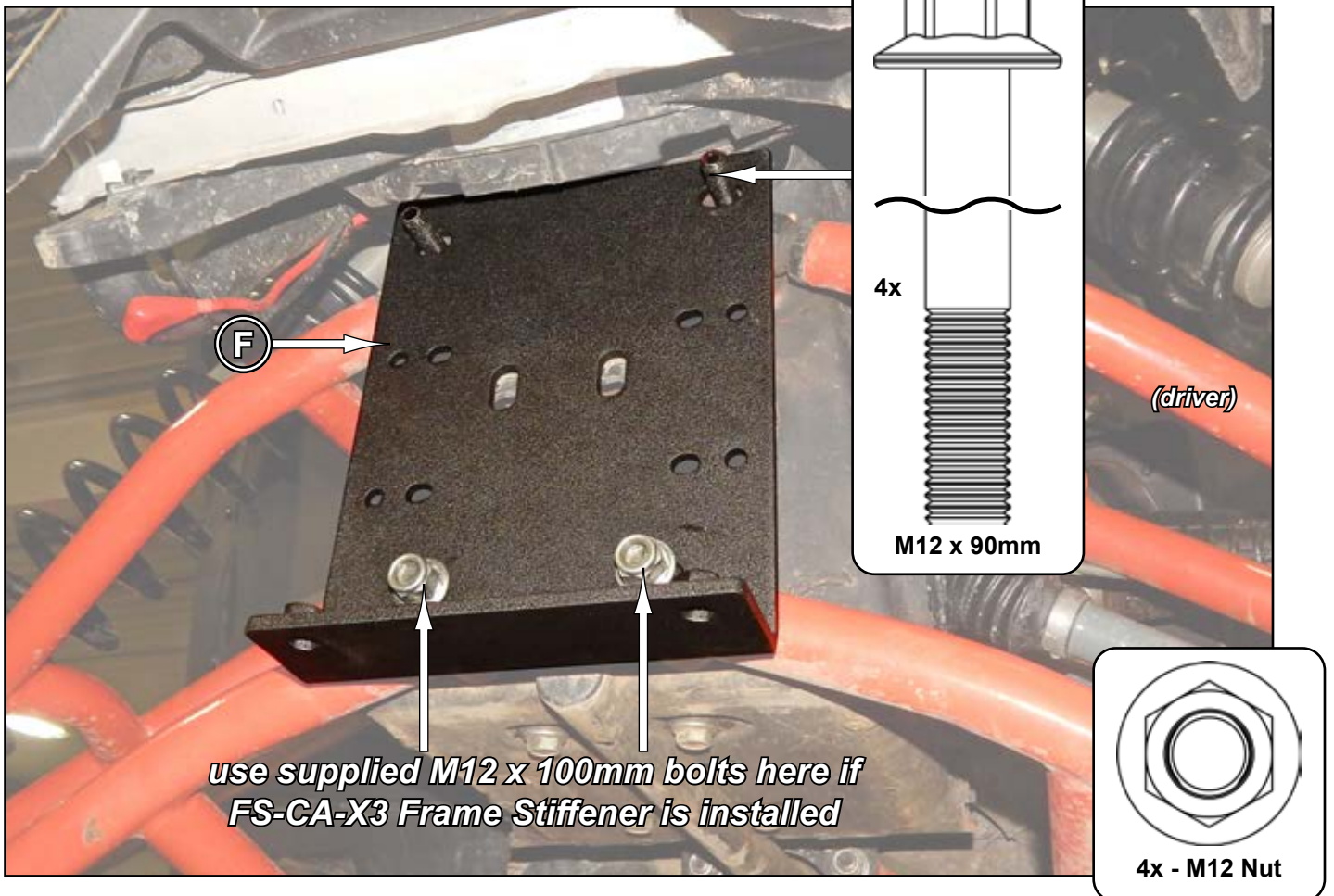
- Remove Front Differential.



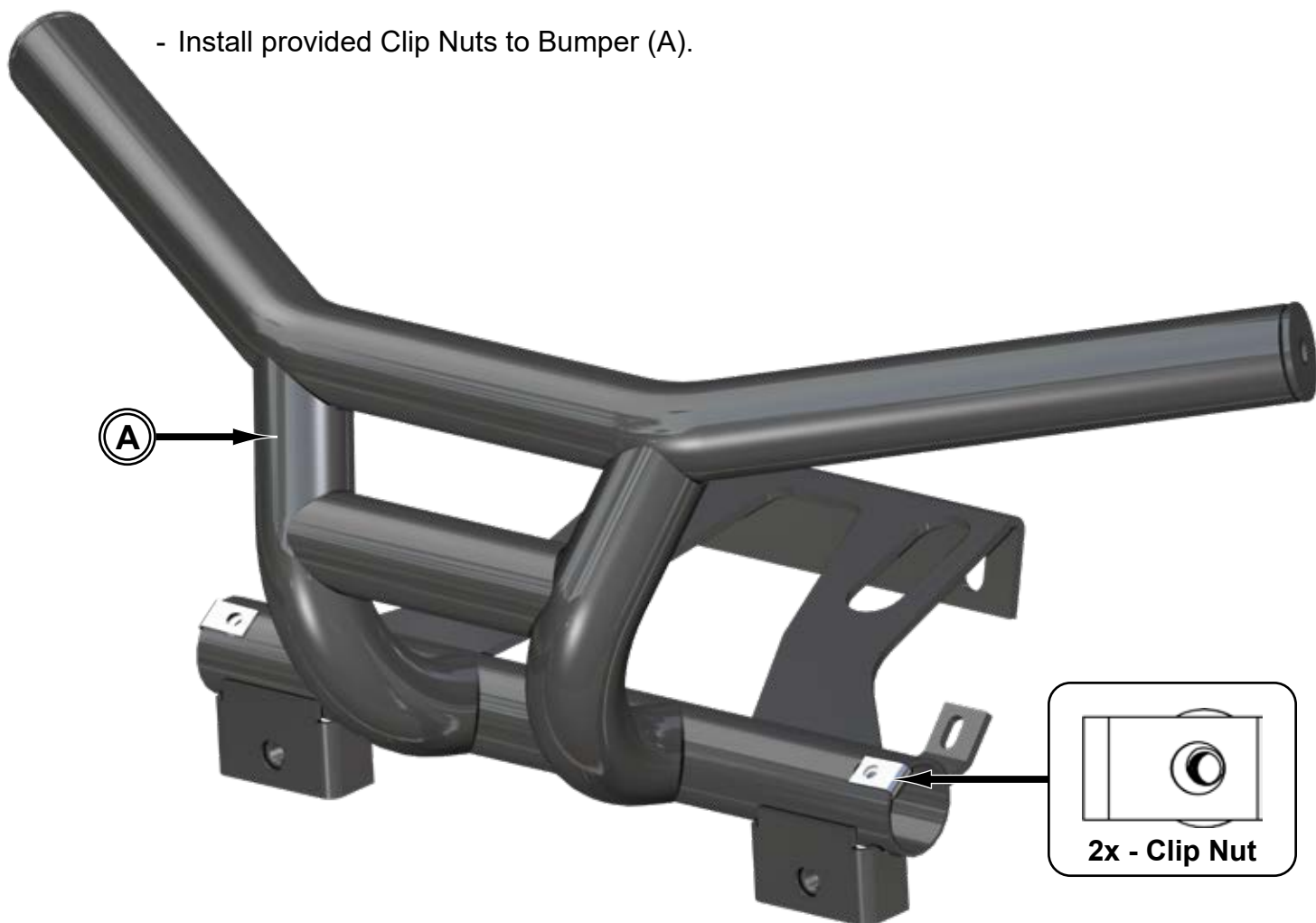
- Remove stock Bulkhead from machine.



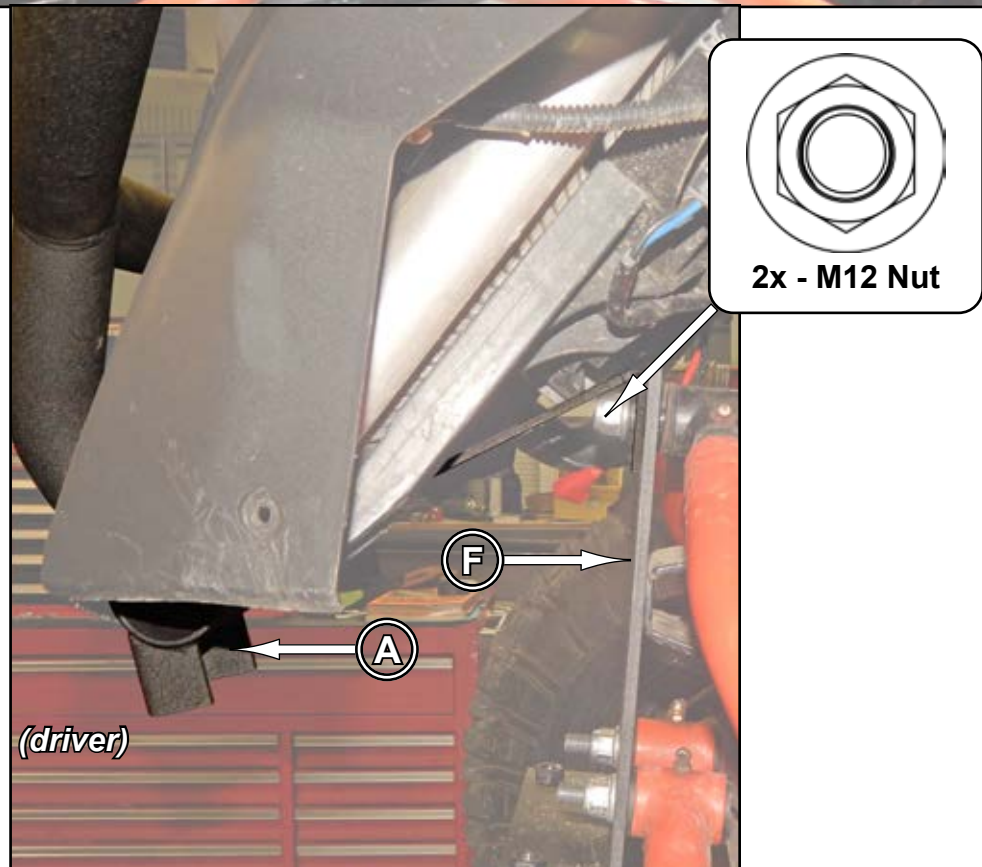
- Install and secure Mount (F) with hardware shown.
- *SuperATV recommends using thread locker on Nuts.*



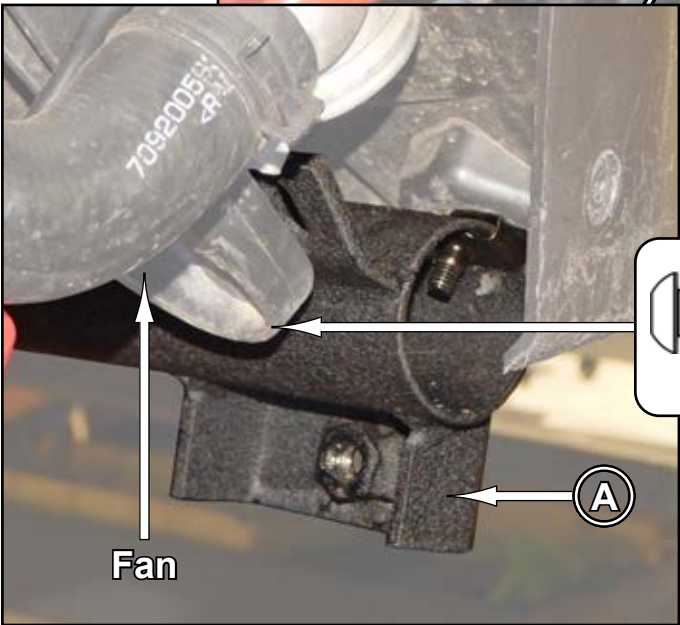
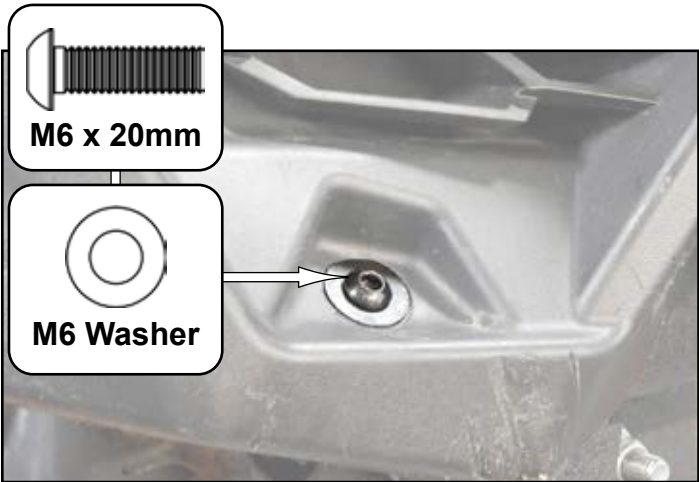
- Install provided Clip Nuts to Bumper (A).



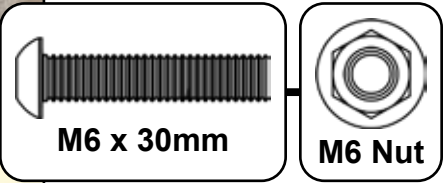
- Secure Bumper (A) to Mount (F) and stock A-Arm hardware with hardware shown.
- If bolts don't align to Bumper (A), raise front of machine off of ground and remove Wheels.
- SuperATV recommends using thread locker on Nuts



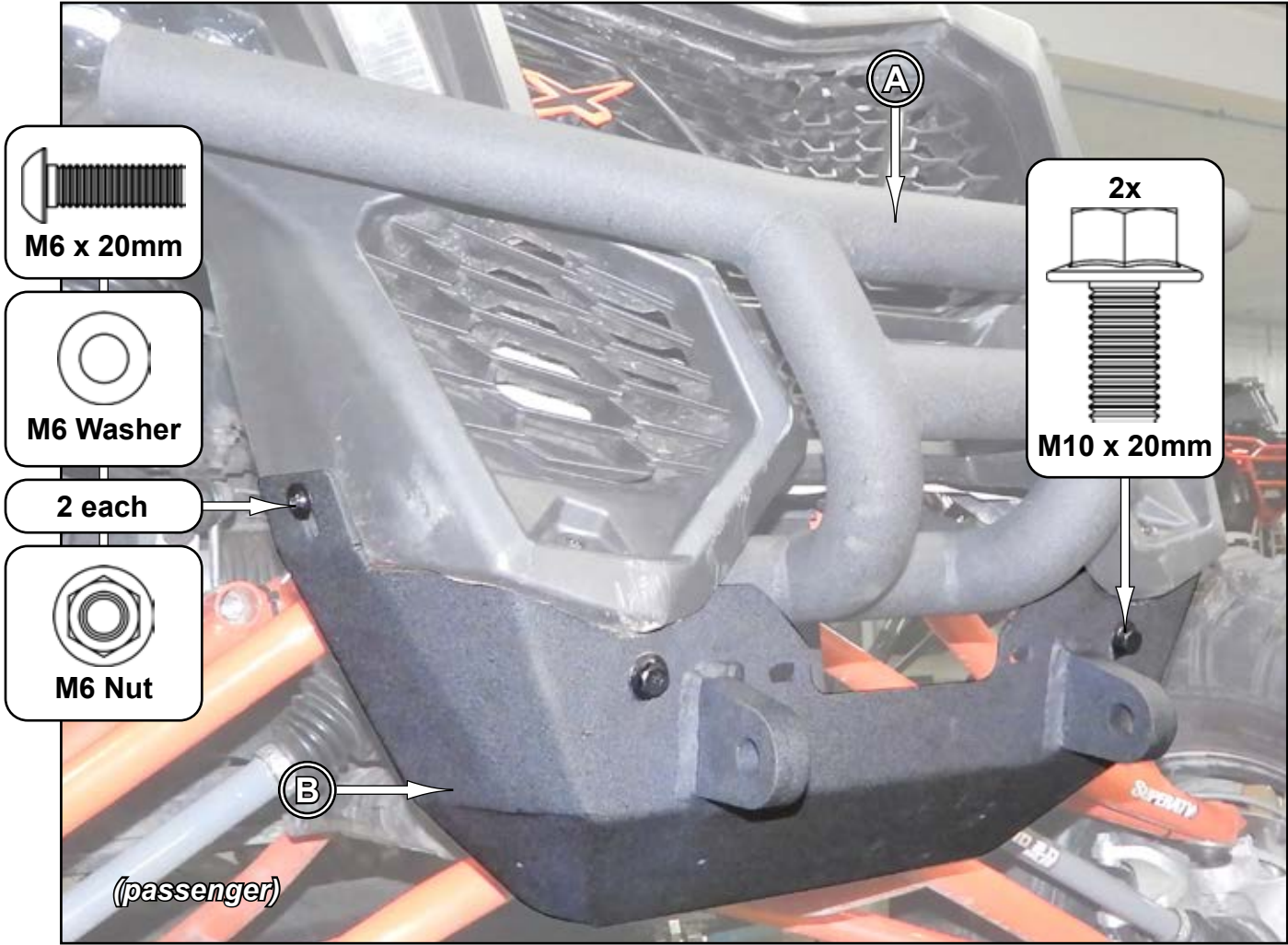
- Secure Front Fascia to Bumper (A) with hardware shown.



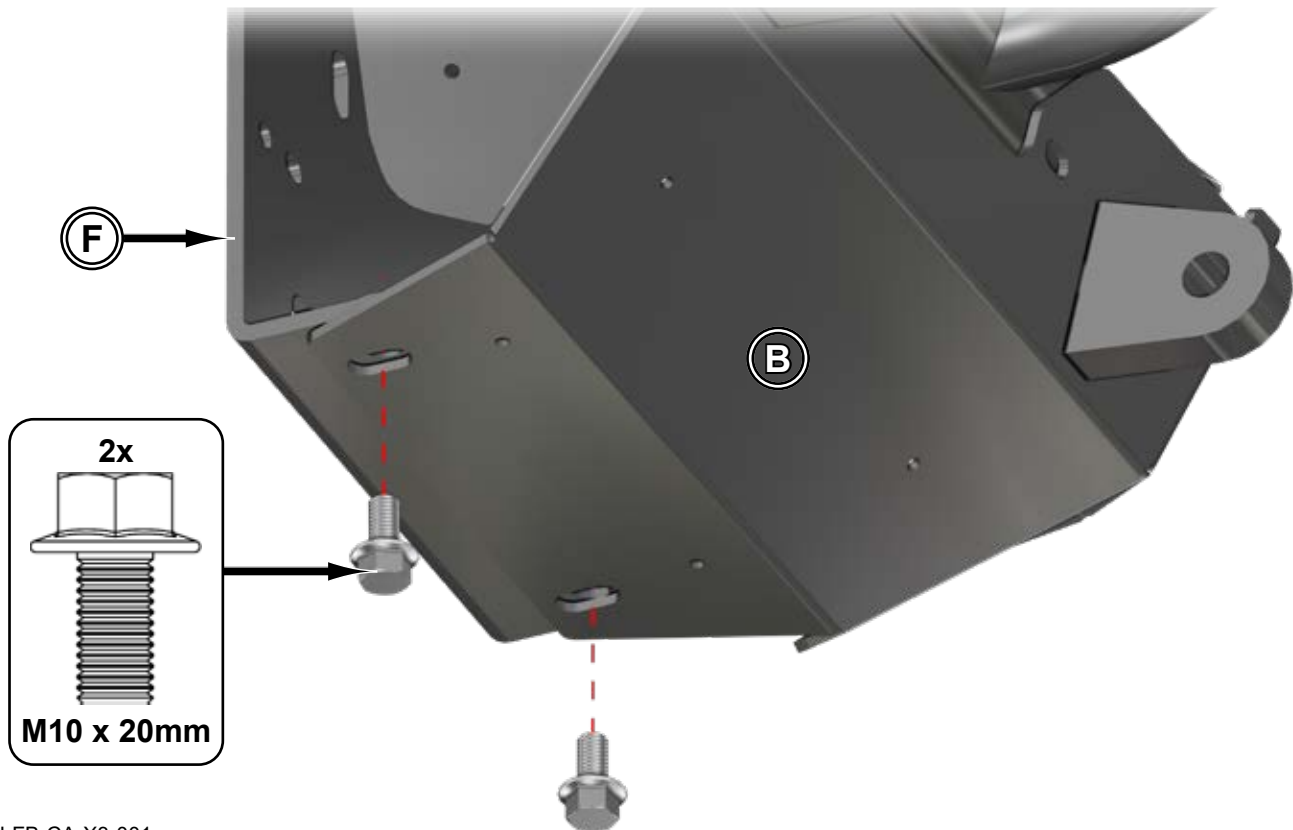
- Secure Fan to Bumper (A) with hardware shown.



- Secure Plate (B) to Bumper (A) and machine with hardware shown.



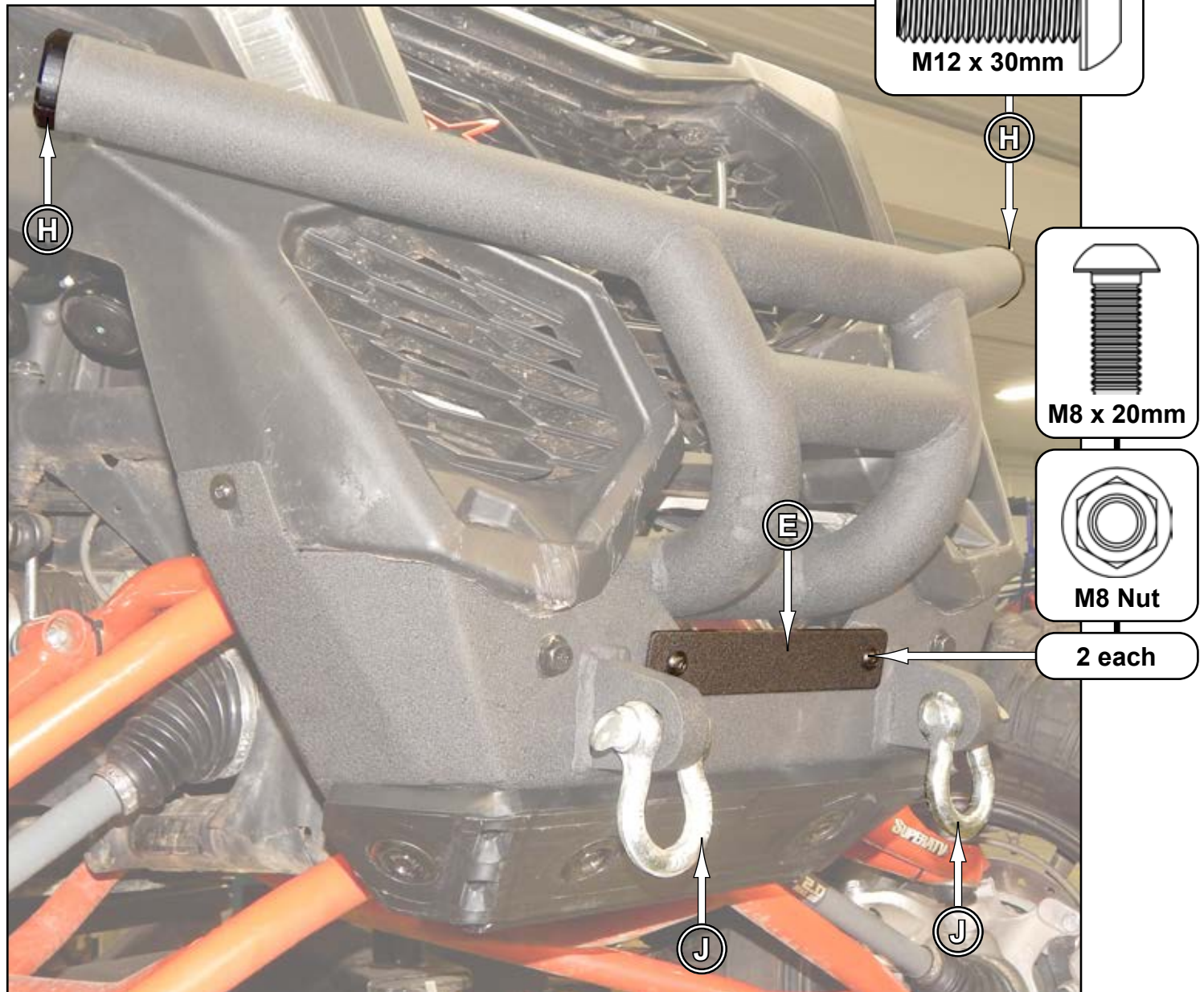
- Secure Plate (B) to Mount (F) with hardware shown.



- Align Bumper assembly to machine and tighten all hardware completely.
- Install Front and Lower Skid Plates (C)(D) to Plate (B) with hardware shown.



- Install Caps (H) to Bumper (A) with hardware shown.
- Install Shackles (J) to Plate (B).
- Install Cover (E) to Plate (B) with hardware shown. *If a Winch is installed, use Adapter (D) or install Fairlead, supplied with Winch, to Plate (B).*
